REPORT

SUMMER OF 2022...SURVIVAL

The previous two summers had been ruined by the Coronavirus epidemic and the more leisurely sport golf adopted by our more senior players at the start of the season. In addition a number of our more talented players joined Kent league clubs to improve their standard of cricket and in many ways, we are delighted to have produced such promising cricketers although it is without doubt we wish they could have spent a little longer with Bidborough Cricket. With other pressures on other individuals having to work more hours, we found a diminishing number of players to sustain our sides. These trends are being found throughout cricket in all parts of the country so we are far from being unique and are comforted that we still have a membership and the support that is envied throughout the village league.

So with a very difficult start to the 2022 season not helped by the first team captain sustaining a broken wrist, we found that we could not sustain four teams and had to cancel games. Indeed at the start of the year we struggled to get out three teams and it was only due to heroic efforts of the three captains and their calling in favours amongst friends that we managed to sustain these three sides throughout. However another trend arising from covid and not playing cricket regularly meant that the attraction of rival events

impacted on availability always being an issue and we rarely reached a point where we could regularly produce sides that fully reflected our abilities.

Coupled with our long term groundsman and our senior umpire having to undergo operations, the first few weeks into the season were difficult with dispiriting defeats across all sides. With the first team bottom of the league, relegation was staring us in the face and after managing to persuade some of our stalwarts back and the benefit of a couple of university boys returning we rallied to win 8 out of the last 10 games resulting in a credible fourth finish.

The second and third teams did rally but only occasionally got the right side of results with the last Saturday of the season producing three wins. On the plus this did point to growing strength in our sides.

Once again we were grateful to our juniors helping out in our senior teams and the continued success of the numbers in our junior section ranging from a starting age of 5 up through our teams to under 15 level. This is a reflection of the hard work by all the organizers and coaches throughout the year. However, we always need more help and anybody who would like to take on coaching qualifications, we would be very happy to assist with financial help. We still want to set up ladies' teams but feel we have to offer more modern facilities before this is viable.

Finance has also been an issue throughout the past couple of years. We have been unable to have the level of fundraising as we have had in the past and with the playing numbers lower also having an impact. As such, we are grateful to our sponsors for their continued support but we are always on the lookout for new sources of support - any ideas or possibilities, please do not hesitate to get in touch.

Dear Parents & Supporters of Bidborough Juniors

I hope to find you all well - I'd like to introduce myself to you and explain some of the new positive changes that are being made to our Junior Section to be implemented over the course of the 2023 winter season.

Over the past few months, the clubs comittee have identified junior cricket as a real growth area for the club, whereby after speaking to many of the comittee (thanks to Alex Latham and co.), I applied and have accepted an invitation to join the club as Director of Junior Coaching.

Ive coached around the London and Kent for around 10 years working within Area Programmes and for the county. Im an experienced Level 2, soon to be Level 3 advanced, qualified cricket coach. I am passionate about cricket and even more about the development of young cricketers. I work

across a few different roles - my main is Lead Coach of Kent CAG U14's. My priority when coaching is to ensure all players are engaged and challenged in each session whilst having fun. I take nothing for granted in my approach to coaching as I still remember my early coaches and cricket experiences they have at Bidborough will be long lasting.

In a snapshot, I want to create an organised and safe environment where the club better engages with the needs of the players and supporters to create a wider sense of community and fun. The club will be sending out further information soon and Im going to send a survey as I want to better understand your views on the junior cricket.

Also, to make an early request, I undoubtedly will need your support, especially during summer season as we've got the opportunity to really create something special.

Junior Cricket Committee

We are also in the process of formalising a Junior committee, terms of which will be confirmed but it is likely to meet 6-8 times per year. Alongside the support previously mentioned, I am seeking a parent representative to stand on the committee. I want to open an additional method to communicate directly into the club. This will also provide an opportunity for parents/supporters to raise things indirectly and still have their voice heard. If you are interested in doing so, please contact me or Susan Steptowe for more information.

Winter Training Programme

Winter training for Under 11's and 13's - we aim to focus on developing a love for all aspects of the game and learning new skills to implement in net practise or match play.

Under 15s and young adults - the focus will be on learning and understanding their games and on surviving and

thriving under pressure and how to put pressure back on oppositions. Strength and conditioning to ensure the players are robust and ready for the season.

This has been based on Kent Cricket's Talent Development Framework.

Bidborough Elite Player Programme (EPP)

Post winter training, the coaches and I will review and identify players who we believe have high potential and will be inviting a small number of players for specialist **1 to 1** and small group coaching sessions during the summer to enhance their provision for cricket. This will come at a small additional cost but the aim is to provide these players with opportunity to develop their skill set in a focused practise and prepare them for next parts of the pathway as they move onwards. More information on this to follow.

For now, I think that covers most things - Im keen to hear any thoughts or field any questions.

THE ARTHUR NICHOLSON

RECREATION GROUND

HAS MAJOR NICHOLSON'S LEGACY BEEN TAINTED

In 1929, Major Herbert Nicholson purchased four plots of land from the Church authorities which totalled just over 10 acres of land and by virtue of a Trust Deed dated 3 August 1929 aifted the land into the possession of Bidborough Parish Council (held in trust). This was done in memory of his son. Arthur who was killed in action in the First World War

This was done for the residents of Bidborough but 'especially for cricket 'but also for all outdoor sports, outdoor recreations and outdoor entertainments as undertaken by those residents. Clearly his wish, which is contained in the Trust Deed, is for a very active area that can be enjoyed on a regular basis by the residents.

Having bought the land, three of the plots of land were thought to be unsuitable for the playing of sport and in the early 1930's, these were sold for housing development with the proceeds allowing for the first pavilion to be constructed in 1935. Major Nicholson was still alive at this point and it is believed that he was fully supportive of these decisions.

Therefore the Recreation Ground (a term used for sports grounds in the 1920's and 30's) is the size we know now although over the years, there have been changes to the land use including the formation of the Bowls Club in 1965 and changes to the play area, particularly when it was revamped in the winter of 1994/5.

When the Trust Deed was established, Major Nicholson decreed that the area should be run by a Committee of Management consisting of three members of the sports clubs (cricket, stoolball and tennis being the three sports existing in 1929) and three members nominated by the Parish Council. His wish was that there should be equal

representation between those who used the ground (namely the sports clubs) and those who paid for the upkeep of the ground (namely the Parish Council). There is no provision for what happens if matters are tied; a clear suggestion that the members need to find solutions that are acceptable to the majority of members on such a Management Committee

It has been suggested that the Bowls Club needs to be

represented on such a committee given that it has been added as a sport since 1965. However the legal advice is that a Trust Deed is difficult to alter and that such alterations are both timely and expensive. In a practical sense, offering observer status to the Bowls Club on the Management Committee would ensure that their voice could be heard on matters that might affect their club

The Management Committee ran in the early years but a significant change occurred with the decision to build a new pavilion in the late 1970's. At this time, the Arthur Nicholson Recreation Ground became registered as a charity while permission was sought from the Charities Commission to lease part of the site to the newly formed Bidborough Sports Association. The site of the new pavilion, the bowls green and the tennis court was to be leased from the Parish Council so that

grants could be obtained from the Sports Council in that they needed an interest in the land before making any grants.

However the Charities Commission were not at all certain that a lease could be granted in relation to the Trust Deed and after an initial refusal, did agree a Deed of Variation in August 1982 although the wording of the lease does suggest that they remain very uncertain whether the granting of a lease would stand up to legal scrutiny. Subsequent leases signed in 2002 and 2017 have not been verified by the Charities Commission and their attitude to such is not known, particularly as the underlying reason for its granting as in obtaining of grants is no longer valid.

With the formation of the Bidborough Sports Association, management and financial responsibility of the leased land moved away from the Manage-

ment Committee and Parish Council respectively. Certainly it looks highly unlikely that the Management Committee was involved in the decision making for extending the play area in the early 1990's in that the Chairman of the Cricket Club complained that it was now directly behind the bowler's arm but this did not appear to have been considered. Incredibly the play area opened in the spring of 1995 without any protective netting such that people were surprised when two balls were hit into the play area on the first weekend of the season. It appears therefore that all parties were not being consulted in that such fundamental issues had not been addressed

Recent years have seen a further diminution of the Management Committee role in this was disbanded in 2002, parish councillors were not informed of their role as Trustees of the ground while the Trust Account

specified in the Trust Deed was closed after funds were spent on equipment not in the Recreation Ground From our research this was all done without any specific legal advice and without any reference to the Charities Commission. It does appear that certain individuals associated with the Parish Council were seeking to nullify the specific provisions contained in the Trust Deed and prevent those involved with the sports clubs in taking their rightful place as part of the decision making process for the ground.

Major Nicholson gave the land to the village for sports and recreation noting that in respect of cricket 'this national game may be always in the forefront of the Village sports and recreation'. Based upon such remarks, it seems that nothing should happen on the ground that interferes with the game of cricket but also that other activities could and should happen on the ground subject to that

proviso. Sporting endeavour is the main purpose of the area and and a wide range of sports should be encouraged.

However to many in the village, it appears that their sole belief is that land should be for walking dogs and for a play area for children and that the original gift for the playing of sport should be over-ridden. The cricket club has no objections to the provision of a play area on the ground but notes that they remain extremely concerned about the dangers of travelling cricket balls such that they will require an area to be completely caged and as far as practical from the cricket square to minimise the danger. They do note that there is an alternative site which would greatly reduce the danger but if it is to be within the confines of the recreation ground, they do require extensive consultation to ensure that the dangers are minimised to prevent an accident which everybody in the community should be seeking.

The Trust Deed does reflect the views and wishes of Major Nicholson. Inevitably the words are a little dated but our legal friends tell us that it is very difficult to change a document. Therefore we do need to respect such a document and we look forward to the cricket season of 2023 with a hope and expectation that the document is properly respected, the role of the sports clubs in making decisions is once again fully restored and a sporting ground with modern and updated facilities can provide a home for those who want sport to prosper, alongside the other activities that fit around the fundamental purpose of the ground.
